

Red Hot Chili Peppers Radio Takeover  
Contest Rules August 2011

**Who Can Enter**

1. Eligible contestants must be legal U.S. residents of the State(s) of California, Connecticut, South Carolina, North Carolina, Georgia, Kansas, Missouri, Massachusetts, New Hampshire, New York, Rhode Island, Virginia, Vermont, Oregon, and Washington, Wisconsin.
2. Eligible contestants must be 18 years of age or older as of date of entry.
3.   - Two concert tickets to see Red Hot Chili Peppers in Los Angeles, California in early, 2012. Exact concert date can/will be disclosed later in 2011 and will provide the date to winner as soon as it’s available and winner agrees to work in good faith with Station to coordinate the trip package.
  - Two roundtrip coach class airline tickets from a commercial airport near the Winner’s city of residence to Los Angeles
  - Two (2) nights hotel accommodations (double occupancy, room only; no incidental expenses, taxes or gratuities included) at a hotel of Station or Sponsor’s choice

#### **Odds of Winning**

21. Odds of winning depend upon number of entries received.
